From the President/CEO

Dear Friends,

Looking back on the last year, I am, as always, immensely proud of our accomplishments, particularly as we worked to deepen our connection to the mission and vision of The Gathering Place. As we faced many changes—structural, programmatic, and external—we did fight indifference; we absolutely insisted on connectedness; and we inspired and were inspired.


I am most pleased that private funding through a variety of sources allowed us to start our Education and Job Readiness program. This has long been a dream of ours and we are grateful for the support of those who made it financially feasible. Now with a staff person who has economic self-sufficiency as her focus, students are rapidly passing the tests necessary to secure a GED. Our members can seek individual advice and counseling as they pursue their goals, and they can attend seminars about resumes, interviewing, and job-seeking skills.

For those who are still struggling with basic survival, we have been actively involved in moving the needle forward in a collaborative effort to obtain more emergency shelter beds for unaccompanied women. We are not invisible. We have been outspoken advocates for the changes necessary to ensure basic human safety. We are partners with the city and fellow nonprofits who have finally secured nighttime shelter space for approximately 65 unaccompanied women—the first substantial increase in emergency shelter beds for women in years. Our collaborative partners have, as we have, been inspired by the resiliency and courage of women who too often have faced the night alone.

These changes would not have been possible without looking within to improve the internal operations of The Gathering Place. Our Governing Board of Directors and our Endowment Board of Trustees, previously legally separate entities, made the decision to merge into one organization focused on both our short and long-term financial needs. We also improved communication and efficiency by streamlining our structure to one that will be responsive and nimble as we continue to respond to economic and environmental changes.

Throughout the year we have benefitted from our strong community of support. Our members, donors, staff, volunteers, and other partners joined together to strengthen who we are and who we will become. Please accept my heartfelt thanks for your confidence in our organization, your generosity, and your commitment to ensuring that The Gathering Place vision is realized.

I want to thank each of you for the tangible gifts of time and money that you give every year. Know that these contributions have led to many intangible gifts, which enhance and enrich our community in ways that are far too valuable to ever be measured. For that we are ever grateful.

Westword articles follow women at The Gathering Place

The cover story of *Westword's* December 6, 2012 issue, “Bed Check,” examined the shortage of shelter beds available for women in the Denver metro area. According to the article, only 252 beds—less than 20% of the shelter spaces in the city—were available for single women at the time of publication, but the 2012 Metro Denver Homeless Initiative Point-in-Time Study estimated that 34% of the city’s homeless population were women.

During the time of the article’s publication, Denver’s Road Home opened a cold weather emergency drop-in shelter on West Colfax with 50 mats available for single women. The shelter moved locations several times, but was still available at the end of the 2012-2013 fiscal year.

While working on the article, writer Sam Levin shadowed a number of women as they participated in the lottery process for both the Women’s Homeless Initiative at St. Francis Center and The Delores Project at The Gathering Place. In addition, Levin interviewed our CEO Leslie Foster and Resource Advocate Ashley Biekarck, who were both quoted in the article.



Starting over: Alicia's story



In late 2009, Alicia was living by herself in a one-bedroom apartment. “The rent started to skyrocket,” she says. “I was paying \$550 a month and my landlord wanted to raise the rent to \$625. With other obligations—public service, phone, groceries, transportation—I couldn’t do it. My pocket only stretched so far. I ended up relinquishing the property and then I was homeless.”

Alicia came to The Gathering Place daily to wash and iron her clothes, to eat meals, and to secure overnight shelter. She also began working with Debra MacKillop, our Housing Stabilization Advocate, to look for a permanent housing solution. “It was a waiting game,” she says. “But while you’re waiting, you have to keep putting one foot in front of the other.” Despite the stress of finding and maintaining shelter,

she managed to keep two part-time jobs, one at a grocery store and one at a large fashion store.

After months of waiting, Alicia moved into her own one-bedroom apartment again. When you ask her what she enjoys most about her new apartment, her answer is simple: “The stability. Now I don’t have to question, first thing in the morning, where am I going to lay my head that night,” she says. “It’s so nice to have one place where you can go and do everything: eat, sleep, have a cup of coffee.”

Belonging: Nataliya's story



Nataliya started coming to The Gathering Place in late 2011. She, her husband, and her son, Timothy, had recently moved to Denver from Los Angeles and she was looking for a place where Timothy could play with other children and she could get help finding resources in the community.

“We can’t afford to do many things in the community. Without The Gathering Place, we’d just be at home in our apartment all day,” Nataliya says. “Timothy can play with other children here and The Card Project gives me something to do. I can see other people and learn about American culture.”

As Kathy Poirier, director of family services, began to get to know Nataliya and Timothy, she noticed that Timothy seemed to be delayed in his language development. She suggested having him evaluated at Child Find, a program of the Denver

Public School system, and Nataliya agreed.

“We learned that he is somewhat delayed, but it is probably because I am teaching him two languages at once,” Nataliya says, noting that he is learning Russian along with English. Timothy was placed in an early childhood learning program at Whittier Elementary, which he attends every day for two and a half hours. He also has a speech therapist visit him at home once a week.

“Timothy’s language skills and his social skills have improved so much since his family started coming to The Gathering Place,” says Poirier.


“Timothy calls The Gathering Place ‘Choo Choo Place’, because of the trains,” says Nataliya. “They are his favorite toy. He is always asking if we can go to Choo Choo Place.”

Writers' Group book published

“A class that arose from a wish became a book that evolved from a dream, a desire that healing words venture beyond a classroom to journey into the world.” —Kirsten Morgan and Suzanne Burm, *One Day, One Night at a Time*

A number of years ago, a group of women at The Gathering Place—many of whom were part of our Writers’ Group—formed a book club. One of the books this group read was about homelessness in Denver. As they read this particular book, the women noted the lack of women’s perspectives and experiences. From that experience came a dream: a dream to write their own book that would be specifically about their experiences with homelessness and poverty.

In April 2013, that dream became a reality with the publication of *One Day, One Night at a Time*. This book, which includes writings by 33 different authors, is a collection of poetry and prose that eloquently reveals the joys and heartaches, struggles and triumphs of their journeys. 
